KLA Water & Waste Policy

Affected Parties: This policy applies to all employees of KLA Corporation and its subsidiaries worldwide.

Policy Statement

KLA is committed to operating in an environmentally responsible manner, in compliance with applicable regulations and in a manner intended to protect and preserve the prosperity of people, environment, and the communities in which we serve.

KLA makes a targeted effort to reduce our waste generation and improve our water stewardship across our organization and promote similar actions to our supply chain partners.

WATER STEWARDSHIP – Water is a shared natural resource that is vital to KLA and its surrounding communities. KLA uses water primarily for manufacturing processes and general building services (sanitation, landscaping, utilities, etc.). Although high quality freshwater is integral to our manufacturing processes, these processes are water-efficient and do not use significant amounts of water. Nevertheless, KLA is committed to improving water stewardship at our manufacturing sites located in areas facing relatively high levels of water stress.

WASTE GENERATION – Waste is a by-product of our business processes that we look to reduce and eliminate where possible. Within our ISO certified systems, KLA commits to pollution prevention and recycling/reuse where prevention is not possible. To demonstrate this commitment, it is important to understand the impact of waste generation on the business and the communities we serve.

KLA PERSONNEL AND OPERATIONS – It is our policy that employees, contractors, and others working on our behalf take appropriate measures to reduce their impact on water resources and waste generation. KLA recognizes that we have operations in water stressed areas and will work with local officials and business groups to promote responsible use of this resource.

SOLUTIONS FOR CUSTOMERS AND SUPPLIERS – Environmental concerns are of increasing importance to our communities, employees, and customers. As a result, KLA will encourage responsible use of natural resources throughout our supply chain and work with stakeholders to responsibly use water and to reduce waste generation.

ACCOUNTABILITY – KLA will operate in an accountable fashion by establishing goals and objectives that will be available to our stakeholders and publish the results of our efforts. Using the baseline year of 2022, KLA will work to set improvement objectives for water conservation and waste reduction efforts.

To improve our water stewardship efforts, KLA will:

a) identify and implement potable water reduction initiatives at our manufacturing locations that may be exposed to near-term or long-term water related risks; and

b) require all our owned and operated facilities to provide adequate water access, sanitation, and hygiene services (WASH).

To improve our waste reduction efforts, KLA will, a) standardize common definitions to facilitate accurate data collection and classification of waste deposition, and b) require targeted KLA facilities to establish local waste reduction efforts to improve over the 2022 baseline.

STAKEHOLDER INVOLVEMENT – We work with stakeholders in the development of standards and practices that reflect the best practical technologies for reducing our impact on water resources and reducing waste generation.

ENVIRONMENTAL SOCIAL GOVERNANCE (ESG) – We strive to incorporate ESG principles into facility design and operate in a manner that efficiently uses resources and reduces waste generation and water consumption. KLA does have operations in water-scarce regions. We will work to reduce our impact on water resources where we operate and encourage responsible use for our employees and downstream supply chain partners. Lastly, we will work to reduce waste generation and preserve resources through material use reductions and recycling and reuse of materials where feasible.

CONTINUOUS IMPROVEMENT – We consider waste generation and inefficient use of resources to be process defects and address them accordingly. We strive to continually improve our management systems and work collaboratively with suppliers and customers to deliver solutions that meet our EHS & ESG objectives.
